



2018 Hope Endowment Fund and CBJ Social Service Grant Reporting Form

Reporting Requirements:

Grantees must submit either an interim or final report on this grant before they are eligible for another grant from the Juneau Hope Endowment. Because the Term of your 2018 grant goes past the 2019 application deadline, all 2018 projects must submit either an interim or final report (narrative and financial) with their 2019 Letter of Interest to be eligible to be considered for a 2019 grant. Interim and final narrative and financial reports should be submitted according to the following schedule.

Interim Report due: by December 28, 2018

Final Report due: by August 31, 2019

Narrative Report: (See Attached)

The narrative report should expand on the **Project Outline** submitted with your application (or as amended through subsequent discussions between the Foundation and your organization) by detailing the **measurable outputs and outcomes** of your program due to the grant you received, e.g., number of people served, number of nights housed, number of people trained, etc. for each of the activities listed in the **Project Outline**.

Please limit additional narrative to two pages and include:

1. Description of modifications, if any, you made in the activities proposed, reasons and implications for the project
2. Discussion of what worked and what did not work, what difficulties you encountered, and any recommendations/suggestions you may have concerning this type of project in the future.
3. List of any press releases sent out and where sent.

Financial Report: (See Attached)

Should include the following:

1. Time period covered by the report (OK to only do through the end of November 2018 for interim report)
2. Accounting of project income and expense formatted to show budget, actual, and any remaining balance. Please work from the budget you submitted or any approved changes to that budget; narrative on financial report should be limited to two pages and describe any significant changes in funding categories that were not previously discussed with the Foundation.
3. Include a statement that funds were used solely for their intended purpose, signed by person who has responsibility for ensuring this is so.
